

On Thursday, June 24, the Public Academical Act was held in full Convocation, the Chief Justice presiding as Chancellor. The Commemorative Oration was delivered by Professor Robb. Mr. Thomas A. Gregory read his Essay on "The Literary and Scientific Characteristics of the Nineteenth Century compared with those of the Augustan Age."

The following Students were admitted Bachelors of Arts:—

The Chancellor presented to Mr. G. G. Roberts the Douglas Gold Medal which had been adjudged to him for his Essay read at the last Encænia; and a similar Medal to Mr. T. A. Gregory for the Essay of the present year; also prizes of Books, as follows:—

For general proficiency, entitling to the Honorary Class at the Examination for Degrees in Michaelmas Term, to Mr. G. G. Roberts, Broetier's Tacitus.

For the same, at the Examination for Easter Term, to Mr. T. A. Gregory, Brande's Dictionary.

For the same, at the Examination in Trinity Term, to Mr. G. E. W. Keator, Scholefield's Euripides and Bell on the Hand; and to Mr. S. H. Sinnott, Dindorf's Sophocles, and Cicero de Finibus.

For proficiency in the Mathematical and Physical Departments, to Mr. W. A. Murray, De Morgan's Differential Calculus; and in the Theological Department, to Mr. J. Davidson, Eusebius' Ecclesiastical History.

The Chancellor proposed as the subject of Essays for the Douglas Gold Medal of the ensuing year, "*Mahomet; his career, and its effects*;" and after making an impressive Address to the Students, he adjourned the Convocation.
