HEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the month of April, 1852, pass an Act, which has been transmitted, entitled as follows, viz:-

No. 2144. An Act to exclude certain persons from serving as

Members of the Legislative Council in this Province.

And whereas the said Act has been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council appointed for the consideration of all matters relating to Trade and Foreign Plantations, and the said Committee have reported as of Trespasses on Crown Lands and Private Property. their opinion to Her Majesty, that the said Act should not receive Her Majesty's Royal confirmation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to declare Her disallowance of the said Act, and the same is hereby disallowed accordingly: Whereof the Governor, Lieutenant Governor, or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice, and govern themselves accordingly. No. 2155. An Act to establish the Road leading from Edmundston, in the Parish of Madawaska, in the County of Victoria, to the River Saint Francis, as one of the Great Roads of communica-

No. 2156. An Act to continue an Act to incorporate the New Brunswick Society for the encouragement of Agriculture, Home Manufactures and Commerce throughout the Province, and to regulate and provide for the same; also an Act to alter and amend the said Act.
