Before the said Corporation shall contract any debts, a certificate shall be filed in the Office of the Secretary of the Province, verified by the oath of the Secretary or other principal officer of the Corporation, which oath any Justice of the Peace is hereby authorised to administer, to the effect that the sum of eight thousand pounds has been actually paid and expended for the purposes of the said Company, and unless such certificate be filed in manner herein directed, within three calendar months after the acceptance of this Charter, the corporate powers hereby conferred shall cease and become of no effect.

10. Nothing in this Act contained shall be construed to interfere with or compromise in any way the rights of the respective parties between whom suits are now pending for any matter, cause or thing which has happened or been committed before the passing of this Act, anything herein contained to the contrary notwithstanding.

11. Notwithstanding the provisions of the eighth section of this Act, the power and authority and provision contained in the said section, to enable the said Corporation to enter upon private property, shall only be deemed and taken to extend to the tract of wilderness land of one mile square, comprised in the lease or licence from the Crown made under the Great Seal of this Province to Peter Duffy and John Duffy, bearing date the eleventh day of January one thousand eight hundred and fifty, and registered in the Office of the Secretary and Register of this Province on the twelfth day of January one thousand eight hundred and fifty; nor shall this Act come into operation or be in force until Her Majesty's Royal approbation be thereto first had and declared.
