## YORK COUNTY.

T a Court of General Sessions of the Peace for the County of York, held at the County Court House, in Fredericton, on the second Tuesday in January 1853, the following Rules and Regulations were passed, pursuant to the powers given by the Act of Assembly passed in the thirteenth year of Her Majesty's Reign, intituled "An Act to consolidate and amend the laws relating to the Local Government of Counties, Towns and Parishes in this Province" !-

1. No Horse, Ox, Sheep, or Swine, shall be allowed to go at large in any Highways in the County of York between the first day of May and the first day of November in each year, under a penalty of two shillings and six pence for every Horse, Ox, or Swine, and six pence for every Sheep so found going at large contrary to this Regu-

2. No Cows, or other cattle, shall be allowed to go at large on the said Highways between the hours of sunset and sunrise in each day, under the penalty of five shillings for each and every offence.

And it is further ordered, That it shall be the duty of all Constables, as well as that of all Hog Reeves and Pound Keepers, within the County of York, to take up and impound all and every the aforesaid animals found running at large contrary to the foregoing Regulations; and they are hereby strictly enjoined to enforce the same in every particular, under the penalty inflicted by law for each and every omission or neglect of duty in this behalf.

#### LOW LANDS AND ISLANDS.

The waters surrounding the several Islands in the River Saint John, in the County of York, and the waters bounding the low Lands fronting upon the Keswick River, in the Parish of Douglas, shall be deemed lawful enclosures of the said Islands and the water fronts of the said low Lands, and any Horse, Cattle, Sheep or Swine entering upon any such Islands or low Lands, by means of such waters, between the first day of May and the first day of October in any year, shall be liable to be impounded in like manner as if such Horses, Cattle, Sheep or Swine had entered thereon by breaking through a fence of the height and description required by law for dividing improved Lands.
