HEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the months of April and May last, pass two Acts, which have been transmitted, entitled as follows, viz:—

No. 2230. An Act to continue the Act suspending the operation of certain provisions of the Militia Laws.

No. 2231. An Act relating to the Coast Fisheries, and for the prevention of Illicit Trade.

And whereas the said Acts have been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council appointed for the consideration of all matters relating to Trade and Foreign Plantations, and the said Committee have reported as their opinion to Her Majesty, that the said Acts should receive Her Majesty's special confirmation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to declare Her special confirmation of the said Acts; and the same are hereby specially confirmed, ratified, and finally enacted accordingly: Whereof the Governor, Lieutenant Governor, or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice, and govern themselves accordingly.

HEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the months of April and May last, pass sixty five Acts, which have been transmitted, entitled as follows, viz:—

No. 2233. An Act to appropriate a part of the Public Revenue for the payment of the Ordinary Services of the Province.

No. 2234. An Act to alter and amend the Act to consolidate and amend the Laws relating to Sick and Disabled Seamen belonging to this Province, not being Paupers, so far as relates to the County of Gloucester.

No. 2235. An Act to amend the Act to facilitate the construction of a Railway from Saint Andrews to Quebec.

No. 2236. An Act to incorporate the Diocesan Church Society

of New Branswick.

No. 2237. An Act for the incorporation of certain Bodies connected with the Wesleyan Methodist Church in New Brunswick.

No. 2238. An Act to authorise the Roman Catholic Episcopal Corporation for the Diocese of New Brunswick to sell, dispose of, and Mortgage Lands in the City and County of Saint John, and to reinvest the proceeds thereof.

No. 2239. An Act to continue and amend an Act more effectually to provide for the support of a Nightly Watch and Day Police in that part of the City of Saint John lying on the Eastern side of the Harbour of Saint John, and for lighting the same, as also for other purposes.

No. 2240. An Act relating to the Fire Police of the City of

Saint John.

No. 2241. An Act to restrain the going at large of Dogs within the City of Saint John.

No. 2242. An Act relating to the Public Debt of the City of Saint John.

No. 2243. An Act for the division of King's Ward, in the City of Saint John, into two separate Wards.

No. 2244. An Act to erect the Parish of Saint Mark, in the City of Saint John, for Ecclesiastical purposes.

No. 2245. An Act to provide against injuries to the Intervale

Banks of the River Saint John.
No. 2246. An Act authorising the appointment of Commissioners

of Sewers in Queen's County.

No. 2247. An Act to unite a portion of a School District in the Parish of Saint David to the Parish of Saint James, in the County of Charlotte.

No. 2248. An Act to authorise the Justices of the Peace for the County of Charlotte to assess the inhabitants of the Parish of Saint Stephen for the erection of a Lock-up House in the said Parish.

No. 2249. An Act to assess a certain District in the Parish of Saint Stephen, in the County of Charlotte, to defray the expense of a Fire Engine, Engine House and other articles connected therewith. No. 2250. An Act for the better and more effectual securing the

Navigation of the River Saint Croix, in the County of Charlotte.

No. 2251. An Act to confirm the Parish Officers elected by the Rate Payers of the Parish of Newcastle, in the County of Northumberland, in January last, in the respective Offices for the year one thousand eight hundred and fifty three.

No. 2252. An Act in addition to and in amendment of an Act intituled "An Act to authorise the Justices of the Peace for the County of Northumberland to erect a Lock-up House in the Town of Chatham, in the said County."

No. 2253. An Act to repeal an Act to amend an Act to consolidate and amend the Laws relative to the local Government of Counties, Towns and Parishes, so far as relates to the County of Victoria.

No. 2254. An Act for altering the time of holding one of the Courts of General Sessions of the Peace and Inferior Court of Common Pleas in the County of Westmorland.

No. 2255. An Act to authorise the sale of the Alms House Property in the County of York.

No. 2256. An Act to appropriate a part of the Public Revenue for the services therein mentioned.

No. 2257. An Act to provide for opening and repairing Roads and erecting Bridges throughout the Province.

No. 2258. An Act to repeal a portion of the Law relating to the collection and protection of the Revenue of this Province.

No. 2260. An Act relating to the Escheating of Mining Licenses or Leases, and also of Mill Reserves, and recovery of Crown Debts.

No. 2261. An Act further to continue an Act to authorise the commutation of Debts due the Crown by Settlers in certain cases, for work on the Public Roads.

No. 2262. An Act regulating Weights and Measures.

No. 2263. An Act in amendment of the Law relating to Inland Posts.

No. 2264. An Act to regulate the granting of Patents for useful Inventions.

No. 2265. An Act to amend an Act for establishing a Tender in all payments to be made in this Province, and for consolidating and amending the Laws relating to the Currency therein.

No. 2266. An Act in amendment of the Act relating to the Election of Representatives to serve in General Assembly, so far as relates to the Polling Places in the County of Carleton.

No. 2267. An Act to establish places for Polling in the Parishes

of Glenelg and Hardwicke, in the County of Northumberland.

No. 2268. An Act to amend an Act regulating the shipping of Seamen at the Port of Saint John, and extend the provisions thereof

to other Ports and places being Sea Ports in this Province.

No. 2269. An Act to amend the Charter of the City of Saint John, and certain Acts of Assembly relating to the local government of the said City.

No. 2270. An Act to amend an Act for the division of King's Ward, in the City of Saint John, into two separate Wards.

No. 2271. An Act to revive and amend an Act to regulate the Herring Fishery in the Parishes of Grand Manan, West Isles, Campo Bello, Pennfield, and Saint George, in the County of Charlotte.

No. 2272. An Act to authorise and empower the Justices of the Peace of the County of York to raise by loan a sufficient sum of money to enable them to erect a new Court House in the said County.

No. 2273. An Act to authorise the Justices of the Peace for the County of Westmorland to assess the inhabitants of the Parishes of Moncton and Salisbury for the erection of a Lock-up House for the said Parishes.

No. 2274. An Act to erect a part of the Parish of Woodstock, in the County of Carleton, into a separate and distinct Town or Parish.
