That there is justly and truly due and payable to him the Complainant, the sum of one pound ten shillings and eightpence or thereabouts of lawful sterling money of Great Britain, being a balance of wages due him for his services as able seaman on board the said ship or vessel, from the thirty first day of July last past to the thirteenth day of September instant, at the rate or wages of two pounds fifteen shillings sterling per month, being the value of his said services on a voyage from the Port of Greenock to Quebec, during which said voyage the said Donald M'Millan was master of the said ship or vessel, which is a British registered vessel, owned by subjects of Her Majesty, proceeding to parts beyond the seas, and doth not belong to any British Colony having a Legislative Assembly.

That the said master neglects and refuses to pay complainant his said wages, although thereunto requested.

Wherefore Complainant prays that the said Master may be summoned to answer this Complainant, and that he be condemned to pay Complainant his said Wages and Costs of suit, together with two days' pay for each day not exceeding ten days of such his neglect and refusal; and the said Complainant hath made his Mark, declaring he cannot write or sign his name.
