CAP. LXVII.

An Act to confirm the conveyance of certain Lands in the City of Saint John, belonging to the Estate of a Lunatic.

Passed 3rd May 1853.

THEREAS by a certain Indenture bearing date the twelfth day of Preambin ⁶ December in the year of our Lord one thousand eight hundred and ' fifty, and made between Hannah Crookshank, the Wife of Robert W. Crookshank, ' Junior, formerly of the City of Saint John, in the City and County of Saint John, ' Esquire, then a Lunatic in Boston, in the United States of America, of the first ' part, Robert W. Crookshank the third, of the City and County aforesaid, 'Esquire, the Committee of the Estate of the said Lunatic, and Elizabeth his ' Wife, and Thomas Otty Crookshank, of the Parish of Simonds, in the County of ' Saint John, Farmer, (the said Elizabeth Crookshank and Thomas Otty Crook-' shank being the sole surviving Children of the said Robert W. Crookshank, ' Junior, and Hannah his Wife,) of the second part, and Robert Carter, of Leaden-' hall Street, in the City of London, Esquire, James Dowie, of Baye Yard, in the said City of London, Esquire, and Alexander Gillispie, of Gould Square, in the said City of London, Esquire, of the third part, after reciting that a suit was ' lately instituted in the Supreme Court of the Province of New Brunswick to ' recover on behalf of the Estate of the said Robert W. Crookshank, Junior, a certain undivided one third part of and in the lot of land and premises thereinafter described, claimed to belong to the said Robert W. Crookshank, Junior, ' or to his said Estate, in which said suit one Alfred Smithers, for and on behalf ' of the Bank of British North America, had been made defendant, pursuant ' to the rules and practice of the said Court, and further reciting that a certain ' agreement was entered into between the parties thereto for the discontinuance · of the said suit, and the payment of the sum of five hundred pounds currency ' by the said Bank of British North America to the parties thereto of the first ' and second parts, upon receiving from them a deed of the said undivided one ' third part of the said lot of land and premises, and of all or any right of dower ' to which the said Hannah Crookshank might thereafter become entitled on the ' death of her said Husband, the said Robert W. Crookshank, Junior, the said ' Lunatic, with covenants for further assurance and confirmation of title, when ' thereafter required, in case of the death or recovery of the said Robert W. ' Crookshank, Junior, such deed to be made to such party or parties as the said ' Bank of British North America should for that purpose appoint; and further ' reciting that the said Bank of British North America had directed and appointed ' that the said deed should be made to and in the name of the said Robert Carter, ' James Dowie and Alexander Gillispie aforesaid; then that indenture witnessed ' that the said Hannah Crookshank, Robert W. Crookshank the third, and ' Elizabeth his Wife, and Thomas Otty Crookshank, for and in consideration of ' the said sum of five hundred pounds of lawful money of New Brunswick to them ' in hand well and truly paid by the said Bank of British North America, the ' receipt whereof was thereby acknowledged, had and each of them had granted,
