A PROCLAMATION.

DY virtue of the power and authority in me vested by an Act made and passed in the fifteenth year of the Reign of Her present Majesty, intituled "An Act to consolidate and amend the Laws relating to the protection and collection of the Revenue of this Province," I hereby declare and proclaim to all whom it doth or may concern, that 1 have, by and with the advice and consent of the Executive Council, extended and by these Presents do extend the Port of Saint John so as to include Musquash; and the Harbour and Port of Musquash, in the County of Saint John, are therefore hereby constituted and appointed a part of the said Port of Saint John, for the admission of Foreign as well as British and Colonial Shipping and Goods, under the Act or Acts of Parliament in such case made or to be made and provided, with all the advantages, and subject to the like regulations, as far as the same are applicable, that the Port of Saint John now possesses or is subject to.

Given under my Hand and Seal, at Fredericton, the ninth day of May, in the year of our Lord one thousand eight hundred and fifty three, and in the sixteenth year of Her Majesty's Reign.

I am to request that, in laying such correspondence before his Grace, you will call his attention to the practice in Her Majesty's Colonial Possessions, more particularly those situated to the East of the Cape of Good Hope, as regards the treatment of the produce of these States in respect of Import duties, and that you will move his Grace to cause the decision of the Lords Commissioners of the Treasury, in this matter, to be communicated to the Governors of those dependencies.
