A PROCLAMATION.

7 HEREAS the General Assembly of this Province stands prorogued to Tuesday the nineteenth day of September instant, I have thought fit to prorogue the said General Assembly, and the same is hereby prorogued to Tuesday the seventeenth day of October next.

> Given under my Hand and Seal, at Fredericton, the thirteenth day of September, in the year of our Lord one thousand eight hundred and fifty four, and in the eighteenth year of Her Majesty's Reign.

Fredericton, Saturday, 23rd Sept., 1854.

This day at four o'clock His Excellency the Lieutenant Governor came down to the Legislative Council Chamber, to meet a large number of the principal inhabitants of Fredericton and its vicinity,

I know that your Address sets far too high a value on all that I or Lady Head have attempted, but in spite of such exaggeration, I receive it with sincere pleasure, because it conveys to us the kindly feelings and the good wishes of those in the midst of whom we have dwelt for the last seven years. In the course of that time I have had a Child born among you; and you may rely upon it, that we shall none of us forget the friends and neighbours whom we leave on the banks of the River Saint John.

On Lady Head's behalf, and on my own, I thank you for the warmth with which you now bid us farewell. May God bless you all, and prosper the City of Fredericton !

MAY IT PLEASE YOUR EXCELLENCY,

We cannot suffer you to retire from the Government of this Colony without attempting to express the regret which we feel at parting with Your Excellency and Lady Head; and we assure Your Excellency that we shall long retain a grateful remembrance of the value of your public services during your administration of the Government of the Colony for the last seven years, a period marked by a rapid progress in the advancement of our social and political condition-in which the Agriculture of the Province has been elevated by scientific investigation and practical instruction of a superior order, imparted for our improvement-our whole Legislative code remodelled, amended, simplified, and abbreviatedour Educational system revised-the Staple Trade and other Commercial relations of the Province advanced beyond all former precedent, and our Provincial Revenues and Resources nearly doubled.

Your Excellency's rapid comprehension and quick dispatch of public business, and your strict regard to justice, have been distinguishing features in Your Excellency's conduct of the Government, which we cannot omit to mention.

We trust we may be excused for giving expression to our deep 100 acres, lot 55, Township 3, P. V. White. sentiments of regard and esteem for Lady Head. Her influence in her high position gave life and refinement to our social intercourse, and her extensive charity has taught the Daughters of our Province that the personal alleviation of sickness and distress adds lustre to the most gifted and accomplished.
