In presenting the above statement to the Subscribers, the Committee would remark, that it is now four years since the Dispensary was established. They trust that it has in a quiet way fulfilled the object of those by whom it was originated, and that few cases of actual distress from want of proper medical treatment have occurred, in which relief has not been promptly afforded. Many who have gone hence, have by this means had their sufferings mitigated, and many by kind attention, the best medical treatment, and proper nourishment, have been restored to health. All this, through the kind services of Dr. Toldervy, has been effected at a very trifling cost. About one hundred cases have received attention during the past year. The Committee regret that the delay in sending in the subscriptions have obliged them to confine their relief chiefly to medicine, and to limit the number of cases in which proper nursing and nourishing diet were much more required.—The Committee cannot but hope that for the coming year a larger amount will be placed at their disposal for an object so worthy of consideration.
