## PROVINCIAL APPOINTMENTS.

**W**ILLIAM DELL HARTT, Esquire, to be a Justice of the Common Pleas for the County of York.

PETER MITCHELL to be a Justice of the Common Pleas for the County of Northumberland.

PATRICK M'NAUGHTON to be a Justice of the Common Pleas for the County of Gloucester.

WILLIAM BRAIT to be Supervisor of the Road from Shediac to Richibucto, in room of William Chandler, Esquire, resigned.

EDWARD ORSER and JOHN BUBAR to be Commissioners to expend £500 granted last Session for the Road from Patchell's Ferry to the County line, Carleton County.
