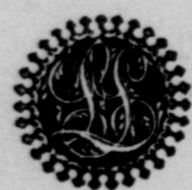

WHEREAS the General Assembly of this Province stands prorogued to Thursday the eleventh day of January instant, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued to Thursday the first day of February next, then to meet at Fredericton for the dispatch of business.

Given under my Hand and Seal, at Fredericton, the sixth day of January, in the year of our Lord one thousand eight hundred and fifty five, and in the eighteenth year of Her Majesty's Reign.

WHEREAS there was this day read at the Board the Draft of a Proclamation declaring the rates at which certain Copper Coins therein described, to be called New Brunswick Pennies and Halfpennies respectively, struck and to be struck at Our Mint in London, are to pass current in Her Majesty's Province of New Brunswick;—

Her Majesty having taken the same into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to Order, and it is hereby Ordered, that the said Proclamation do take effect and come into force in Her Majesty's said Colony upon, and from and after the promulgation thereof by the Lieutenant Governor or Officer administering the Government of the said Colony.

And the Lords Commissioners of Her Majesty's Treasury, and the Right Honorable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, are to give the requisite directions for causing publication to be made thereof in Her Majesty's said Colony, and for the other purposes referred to therein accordingly.

WHEREAS certain pieces of Copper Money have been coined at Our Mint in London, called a Penny and Halfpenny of New Brunswick Currency respectively; the Penny having for the obverse impression Our Effigy, with the inscription, "Victoria Dei Gratia Regina," with the date of the year, and for the reverse

a Ship on the Waves of the Sea, Proper, with the inscriptions "New Brunswick," "One Penny Currency;" the Halfpenny having for its obverse impression Our Effigy, with the inscription "Victoria Dei Gratia Regina," with the date of the year, and for the reverse a Ship on the Waves of the Sea, Proper, with the inscriptions "New Brunswick," "Halfpenny Currency;"

We have, therefore, by and with the advice of our Privy Council, thought fit to issue this Our Royal Proclamation, and We do ordain, declare and command that the said pieces of Copper Money so coined, or to be coined, shall be current and lawful Money within our Province of New Brunswick, and shall pass and be received as current and lawful Money therein by name and names aforesaid, and at the values of one Penny currency and one Halfpenny currency respectively.



Given under the Great Seal of our Province of New Brunswick. Witness our trusty and well beloved the Honorable JOHN HENRY THOMAS MANNERS SUTTON, at Fredericton, the eighth day of January, in the year of our Lord one thousand eight hundred and fifty five, and in the eighteenth year of Our Reign.
