HEREAS the General Assembly of this Province stands prorogued to Thursday the sixth day of December next, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued to the second Thursday in January next ensuing.

A PROCLAMATION.

THEREAS by an Act of the Imperial Parliament passed in the eighteenth and nineteenth years of the Reign of Her present Majesty, entitled "An Act to amend the Law relating to the carriage of Passengers by Sea," it is provided that it shall be lawful for the Governor of each of Her Majesty's Possessions abroad, by any Proclamation to be by him from time to time issued for that purpose, to declare what shall be deemed, for the purposes of this Act, to be the length of the voyage of any ship carrying Passengers from such Possession to any other place whatsoever, and to prescribe such scale of Diet for the use of the Passengers during the voyage as he shall think proper, and also to declare what medicines, medical comforts, medical instruments, and other matters shall be deemed necessary for the medical treatment of the Passengers during such voyage ;-

Now, therefore, under the power and authority in me vested by the said Act of Parliament, I do hereby proclaim and declare that the length of a voyage of a "Passenger Ship" proceeding from this Province to the undermentioned places shall be determined by the

following scale, viz :-If the ship be propelled by sails alone, or by steam power not sufficient without the aid of sails to propel the ship after the rate of five statute miles an hour-

From hence to Europe:

1st. For ships clearing out between the 16th day of January and the 14th day of October, both days inclusive, seventy days,

2nd. For ditto between 15th October and 17th January, both

days inclusive, eighty days.

Central or South America north of the Equator, seventy days.

4th. To any part of the East Coast of South America lying between the Equator and the 25th degree of sonth latitude, eighty four days.

5th. To the West Coast of Africa north of the Equator, eighty

four days.

6th. To the Coast of Africa south of the Equator, or to the Falkland Islands, or to any part of the East Coast of South America, southward of the 25th degree of south latitude, one hundred and five days.

7th. To the Mauritius, and to the Western Coast of America south of the Equator, one hundred and twenty six days.

8th. To Ceylon, one hundred and forty days.

9th. To Western Australia, one hundred and twenty days.

10th. To any other of the Australian Colonies, one hundred and forty days.

11th. To New Zealand, and to the Western Coast of America By His Excellency The Honorable John Henry between the Equator and the fortieth degree of north latitude, one hundred and fifty days.

12th. To the Western Coast of America north of the fortieth degree of north latitude, and the Islands adjacent thereto, one hundred and eighty two days.

If the ship be propelled, either wholly or in aid of sails, by steam engines of not less power than sufficient, without the aid of sails, to propel the ship after the rate of five statute miles an hour, then for the first place above mentioned, forty days,

For the second, forty five days,

third, forty days, fourth, fifty days,

fifth, fifty days, " sixth, sixty five days, seventh, seventy five days, eighth, eighty five days,

ninth, eighty five days, tenth and eleventh, ninty days each, and

twelfth, ninety six days.

And I do hereby further proclaim and declare that the supply of medicines, medical instruments, and other matters necessary for the medical treatment of the Passengers during the said several voyages. shall be regulated in accordance with the forty third Section of the said Act, and that the water and diet for Passengers shall be regulated in accordance with thirty fifth Section of the same Act.

CIVIL SERVICE OF INDIA.

1. In July 1856, an examination will take place of candidates for 3rd. To the West Indies, and any part of the East Coast of appointments to the Civil Service of India. Notice will be hereafter given of the days and place of examination.

> 2. Any natural-born subject of Her Majesty, who shall be desirous of entering the Civil Service of India, will be entitled to be examined at such examination, provided he shall, before the 1st of May, 1856, have transmitted to the India Board, Cannon Row, Westminster :-

(a) A certificate of his birth, showing that his age, on the 1st of May, 1856, will be above eighteen years and under twenty three years.

(b) A certificate, signed by a physician or surgeon, of his having no disease, constitutional affection, or bodily infirmity, unfitting him for the Civil Service of India.
