A PROCLAMATION.

BY virtue of the power and authority by Law vested in the Governor in Council, I hereby declare and proclaim to all whom it doth or may concern, that I have, by and with the advice and consent of the Executive Council, diminished the extent of the Port of Dalhousie, in the County of Restigouche, to that part of the said County which lies to the eastward of a line drawn from Maple Green to the northwest angle of the County of Gloucester; and I do hereby, by and with the advice aforesaid, declare and proclaim Campbellton, in the said County of Restigouche, to be a Port of Entry; and I do declare all that part of the County of Restigouche which lies to the northward and westward of the said line so drawn from Maple Green, to the northwest angle of the County of Gloucester, to be the Port of Campbellton; and the said Port of Campbellton is therefore hereby constituted and appointed a Port for the admission of Foreign as well as British and Colonial Shipping and Goods, under the Act or Acts of Parliament in such case made or to be made and provided, and subject to Regulations established by the Imperial Customs in that behalf.
