# LEGISLATIVE COUNCIL CHAMBER

FREDERICTON, SATURDAY, JULY 26, 1856.

This day at three o'clock His Excellency the Lieutenant Governor came in the usual state to the Council Chamber, and being seated on the Throne, commanded the attendance of the House of Assembly, who being come, His Excellency was pleased to close the Session with the following Speech:

- "Mr. President, and Honorable Gentlemen of the Legislative Council,
- "Mr. Speaker, and Gentlemen of the House of Assembly,
- "I thank you for the attention which you have given to the public business.
- "The measure which you have passed, and to which I have readily given my assent, for the repeal of the Act prohibiting the importation and manufacture of, and traffiein, Intoxicating Liquors, will have a material effect in improving the financial condition of the Province; and, intimately acquainted as you are with the feelings of the People, I do not doubt that this measure is in accordance with their wishes.
- "In relieving you from further attendance, I desire to assure you of my cordial good wishes for the success of the avocations to which you will now return."
