WHEREAS the General Assembly of this Province stands prorogued to Tuesday the eighteenth day of August instant, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued accordingly to the fourth Thursday in September next.

Given under my Hand and Seal, at Fredericton, the twelfth day of August, in the year of our Lord one thousand eight hundred and fifty seven, and in the twenty first year of Her Majesty's Reign.

SIR,—With reference to my Despatch of the 13th November, I transmit herewith the copy of an Order of Her Majesty in Council authorizing the levying of a Toll on Ships passing or deriving benefit from the Light House erected on Cape Race, Newfoundland.

AT THE COURT AT BUCKINGHAM PALACE,
The 16th day of July 1857.

PRESENT:

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS by the "Merchant Shipping Act Amendment Act, 1855," it is enacted, that in case in which any Light House had been or should be thereafter erected or placed on or near the coasts of any British Possession, by or with the consent of the Legislative authority of such Possession, Her Majesty might, by Order in Council, fix such dues in respect thereof, to be paid by the Owner or Master of every Ship which passes the same or derives benefit therefrom, as Her Majesty might deem reasonable.

And whereas a Light House has, by and with the consent of the Legislative authority of the Colony of Newfoundland, been erected on Cape Race, in the said Colony, and a light is already exhibited therein.

And whereas the several classes of ships following, that is to say:—

All ships, whether sailing ships or steamships, navigating from any port or ports in the British Colonies in North America, to any port or ports in the United Kingdom;

All ships, whether sailing ships or steamships, navigating from any port or ports in the United Kingdom, to any port or ports in the British Colonies in North America;

All ships, whether sailing ships or steamships, bound from any port or ports in the British Colonies in North America upon any Transatlantic voyage;

All ships, whether sailing ships or steamships, arriving in any port or ports in the British Colonies in North America, after any Transatlantic voyage;

All ships, whether sailing ships or steamships, arriving at any port or ports in the United Kingdom, from New York, or any port in the United States north of New York;

All steamships leaving any port or ports in the United Kingdom for New York, or any port in the United States north of New York;

Will pass the said Light House, and will derive benefit therefrom.

Now therefore, Her Majesty, in exercise of the powers vested in Her by the said recited Act, by and with the advice of Her Privy Council, is pleased to direct, that, from and after the date of this present Order, the dues in respect of the said Light House upon Cape Race, to be paid for every such ship as aforesaid, except ships belonging to Her Majesty, Her Heirs and Successors, shall be one-sixteenth of a penny per ton of the burden of every such ship, for every such voyage as aforesaid.

But no such dues as aforesaid, shall be levied in any Colony, unless and until the Legislative authority in such Colony has, either by address to the Crown, or by an Act or Ordinance duly passed, signified its opinion that the same ought to be levied in such Colony.
