## A PROCLAMATION.

To all Sheriffs, Justices of the Peace, Revenue Officers, and others, Her Majesty's Subjects, Inhabitants of the Province of New Brunswick, Greeting:—

**W**HEREAS it has been officially notified to me, that the Honorable JOHN HAMILTON GRAY, of this Province, has, under the first Article of the Treaty relative to Fisheries and to Commerce and Navigation concluded at Washington on the fifth day of June in the year one thousand eight hundred and fifty four between Great Britain and the United States of America, been appointed Arbitrator or Umpire to determine differences of opinion which have arisen between the Commissioners appointed by Her Majesty and the United States of America under the said Treaty; and Her Majesty's Commissioner having reported that the said Arbitrator or Umpire is about to visit the Coasts of this Province, and Rivers thereof flowing into the Gulf of Saint Lawrence, in the discharge of his duties: I have thought fit to direct and require, and I do by these presents require you and each of you, to give to the said Arbitrator or Umpire such information and aid as he, in the execution of his duties, may request from you.
