HEREAS the General Assembly of this Province stands prorogued to Thursday the eighth day of January next, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued accordingly to Thursday the twelfth day of February next, then to meet at Fredericton for the despatch of business.

Given under my Hand and Seal, at Fredericton, the twenty seventh day of December in the year of our Lord one thousand eight hundred and fifty six, and in the twentieth year of Her Majesty's Reign.

THEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the month of May 1856, pass two Acts,

which have been transmitted, entitled as follows, viz:-No. 2486. An Act relating to the Collection of the Revenue. No. 2498. An Act to explain Chapter 120, Title xxxi, of the Revised Statutes, "Of Banking."

And whereas the said Acts have been laid before Her Majesty in Council, together with a Letter from the Right Honorable Henry Labouchere, one of Her Majesty's Principal Secretaries of State, to the Lord President of the Council, recommending that the said Acts should be left to their operation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to approve the said recommendation: Whereof the Governor, Lieutenant Governor, or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
