The expenditure having exceeded that of past years, the Committee found it necessary to make a more general application for contributions. They were much encouraged by meeting, in almost every instance, a ready answer to their appeal, at a time too when in other ways there are frequent applications for assistance to the poor.

During the past year more than the usual number of applicants have received attention; very many of these have required frequent prescriptions and advice, and in several cases of fever, daily visits at the patients' houses. In several instances great relief has been afforded by the supply of proper diet during convalescence.
