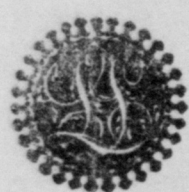

WHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and As-

sembly of the said Province, did in the months of March and April 1858, pass sixty eight Acts, which have been transmitted, entitled as follows, viz:—

No. 2573. An Act to provide for defraying certain expenses of the Civil Government of the Province.

No. 2574. An Act to provide for the repair and improvement of Roads and Bridges, and other Public Works and Services.

No. 2575. An Act to compel the attendance of Witnessess under Commissions from other Countries, and in further amendment of the Law of Evidence.

No. 2576. An Act in amendment of an Act relating to the Public Debt of the City of Saint John.

No. 2577. An Act to enable the Corporation of the City of Saint John to meet their liabilities incurred in erecting Wharves at or near Reed's Point, in the City of Saint John.

No. 2578. An Act in addition to and amendment of an Act intituled "An Act to authorize that part of the City of Saint John called Carleton, to obtain Water from Spruce and other Lakes, and the Mayor, Aldermen and Commonalty of the said City to issue Scrip to defray the expenses of so doing."

No. 2579. An Act authorizing the Commissioners under an Act to provide for an improved System of Water Supply and Sewerage of the City of Saint John and Parish of Portland, to increase the amount of issue of Debentures, and making other provisions for the better carrying out the objects of that Act.

No. 2580. An Act to amend the Act for the incorporation of certain Bodies connected with the Wesleyan Methodist Church in New Brunswick.

No. 2581. An Act relating to Parish Schools.

No. 2582. An Act to amend Chapter 40, of Title iv, of the Revised Statutes, "Of the Post Office."

No. 2583. An Act to amend Chapter 28, Title iii, of the Revised Statutes, "Of Warehousing Goods."

No. 2584. An Act to repeal an Act intituled "An Act to amend Title iii, Chapter 20, of the Revised Statutes, "Of the Regulation of Light Houses," and make other provisions.

No. 2585. An Act to compel Vessels navigating the Bay of Fundy to carry Lights.

No. 2586. An Act to encourage the destruction of Wolves in this Province.

No. 2587. An Act to prevent the use of Poisons in the destruction of Foxes and other animals.

No. 2588. An Act to alter the times for holding the Circuit Courts in the Counties of Westmorland and Albert.

No. 2589. An Act to amend the Law for the relief of Insolvent Debtors.

No. 2591. An Act relating to Co-Partnerships.

No. 2592. An Act to amend the Practice of the Law.

No. 2594. An Act in amendment of the Criminal Law.

No. 2595. An Act to amend and explain Chapter 126, of Title xxxiv, of the Revised Statutes, "Of Landlord and Tenant, and Replevin."

No. 2596. An Act in addition to Chapter 113, of Title xxx, of the Revised Statutes, "Of Judgments, Executions, and proceedings thereon."

No. 2597. An Act relating to Dower.

No. 2598. An Act to amend the Act relating to intestate Estates.

No. 2599. An Act to continue and amend an Act relating to Steam Navigation in this Province.

No. 2600. An Act for the more effectual preservation of the Peace within the Boundaries of the New Brunswick and Canada Railway and Land Company.

No. 2601. An Act in addition to Chapter 64, Title viii, of the Revised Statutes, "Of the local government of Counties, Towns and Parishes."

No. 2602. An Act to alter and amend an Act intituled "An Act relating to Highways."

No. 2603. An Act to authorize the establishment of a Great Road leading from the mouth of the Gaspereaux River, in Queen's County, to the South West Bridge on the River Miramichi.

No. 2604. An Act to amend Chapter 101, of Title xxii, of the Revised Statutes, "Of the Sea and River Fisheries."
