Licences to teach will be granted by the Board as of the 1st, " 2nd, or 3rd Class, agreeably to the periodical classifications of the "Teachers and Candidates, made by the Board on the Reports " from the Training School, to such applicants as shall have attended "that Establishment, been finally examined there, and received the " necessary certificates of character and competency."
