HAVELOCK MEMORIAL FUND.

At the Meetings of the Committee, held at No. 3, Pall Mall East, on Wednesday the twentieth and on Friday the twenty ninth January 1858—

Sir Macdonald Stephenson in the Chair,—It was unanimously resolved, That the object of the Committee is the erection of a

the late General Sir Henry Havelock, K. C. B., and his brave companions in Arms. That with a view to most effectually carrying out the wishes of the public, a Statue be erected upon a suitable site to be hereafter decided on.

That any surplus funds be appropriated to an endowment for the benefit of the Widows and Orphans of Officers and Soldiers who have fallen in the recent Battles and Victories under General Havelock, and who are so honorably associated with his name and memory; to a suitable memento to his Widow and Daughters, or to such other purposes, as it may hereafter be ascertained by the Committee, would have met with the approval of the late distinguished General.

That the Mayors and Corporations of the principal Cities and Towns of Great Britain and Ireland be invited to co-operate with the Committee in carrying out the above object, and that they be requested to receive subscriptions.

That subscriptions be invited from India. That in order to afford to all classes the opportunity of contributing towards this truly national undertaking, the amount of individual subscriptions is left open, and the smallest will be cheerfully received.

The Committee have great pleasure in announcing that Her Majesty's Government, with the express sanction and approval of Her Majesty, have granted the site in Trafalgar Square for the erection of the Statue to Sir Henry Havelock.
