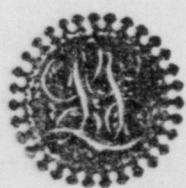

FREDERICTON, NOV. 16, 1859.

**T**HE School Trustees and Teachers throughout the Province, are hereby notified that the Schools in the different Districts will be visited by the several Inspectors, during the present Term, in the following order:—

**EASTERN DISTRICT.**—Inspector DUVAL.

*King's.*—The Inspector is now visiting the Western Parishes; the Eastern Parishes will be visited at the end of the Term.

*Albert.*—In March.

*Westmorland.*—In April.

**WESTERN DISTRICT.**—Inspector M'LAUCHLAN.

*Carleton and Victoria.*—The Inspector is now visiting these Counties, and will complete the inspection by the middle of January.

*York.*—From middle of January to end of February.

*Sunbury.*—In March.

**SOUTHERN DISTRICT.**—Inspector CAMPBELL.

*Charlotte.*—Saint Patrick, Saint George, Pennfield, Dumbarton, Saint David, and Saint James, in November; Saint Andrews, and Saint Stephen, the first part of December; Lepreau, in January.

*Queen's.*—This County will be visited in January and February, beginning at Petersville.

*Saint John.*—Commencing in February, with the Schools in the City, and then to proceed until inspection is completed.

**NORTHERN DISTRICT.**—Inspector BENNET.

*Gloucester.*—Commencing 28th November, in the following order:—Beresford, Bathurst, New Bandon, Caraquet, Shippegan, Inkerman, and Saumarez.

*Restigouche.*—About the 19th December, as follows:—Durham, Colburn, Dalhousie, Addington.

*Kent.*—About the 9th January, as follows:—Carleton, Palmerston, Richibucto, Weldford, Wellington, Dundas.

*Northumberland.*—About 6th February, as follows:—Hardwicke, Glenelg, Chatham, Nelson, Derby, Northesk, Blackville, Blissfield, Ludlow, Newcastle, Alnwick.

In addition, a meeting of the Licenced Teachers of York County will be held at the School House of Mr. Solomon Denton, on Friday the 23rd December, at 10 A. M. The Chief Superintendent and District Inspector likewise design holding a series of public Educational Meetings during the Winter in the Counties of York, Carleton, and Sunbury, of which due notice will be given.
