A PROCLAMATION.

BY virtue of the power and authority in me vested, I hereby, with the advice and consent of the Executive Council, declare and proclaim to all whom it doth or may concern, that I have extended the Port of Saint John on the West side of the Harbour, in the City and County of Saint John, and the same is hereby extended as follows, viz :--

"From the City Line, near Clark's Wharf, to the point known and distinguished as Sand Point;" The whole on the East side as heretofore established, and the extension on the West side, to constitute one Port, and to have the same rights and privileges, and be subject to the same Rules and Regulations.

> Given under my Hand and Seal, at Fredericton, the second day of May, in the year of our Lord one thousand eight hundred and fifty nine, and in the twenty second year of Her Majesty's Reign.
