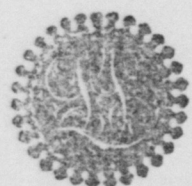

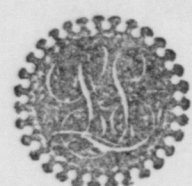
### A PROCLAMATION.

### A PROCLAMATION.
