ART 9, Section 2, of Post Office Regulations is repealed, and the following adopted, viz :--

Printed Books, Periodical Publications or Pamphlets, under sixteen ounces in weight, can be forwarded by Post in New Brunswick, at the rate of one half penny per ounce.

Printed Music will be allowed to pass through Post in New Brunswick, under the same Regulations as Pamphlets.

Printed Circulars, Catalogues, Hand Bills, and Prices Current 150 acres, lot 23, block 6, Moncton, Robert Peters. posted in New Brunswick, will be liable to a rate of one half penny 200 acres, lot 156, block 7, Moncton, Stewart Grant. each, subject to the following Regulations, viz :--
