The subjects of Examination will be:—The first Book of Herodotus, Fourth of Homer's Iliad, Third of Livy, and Sixth of Virgil's Aeneid; the Definitions, Axioms, and First Book of Euclid, Arithmetic and Algebraic Fractions; and English and Latin Composition:—with all which subjects Candidates are expected to discover an intelligent acquaintance. The Scholar is required to reside in the College, and discharge the duties of Librarian.

Some County and Divinity Scholarships are also vacant. For the former, application must be made to the Masters and Trustees of the respective Grammar Schools. The latter may be obtained on application to the Lord Bishop of Fredericton.
