HE following Rules and Regulations have been made and passed by His Excellency the Lieutenant Governor with the advice and consent of the Executive Council :-

#### RULES AND REGULATIONS

For the protection of the Fisheries on the Sea Coasts and around the Islands in the County of Charlotte.

1. That no person shall set any net, or cast or draw any seine, or otherwise catch any fish from sunset on Saturday until sunrise on the following Monday morning, on the sea Islands in the County of Charlotte, between low water mark and three marine miles from the shore, under a penalty of ten pounds for each offence, or imprisonment for ten days.

2. That whenever the Fish Warden may determine that gates in fish weirs are necessary, the owner or owners of such weirs, or person using the same, shall cause the said gates to be kept open from sunset on Saturday until sunrise on the following Monday morning, under a penalty of fifteen pounds for each offence.

3. That no person shall set any line or lines on which are placed hooks to catch fish, within three marine miles of the said Coasts or Islands, under a penalty of fifteen pounds, or ten days imprisonment for each offence.

4. That the third Regulation shall not apply to catching fish by hand lines in the hands of the Fishermen at the time.
