A PROCLAMATION.

BY virtue of the power and authority in me vested by the provisions of an Act made and passed in the twenty third year of the Reign of Her present Majesty Queen VICTORIA, intituled 'An Act relating to the Militia Law,'—

I do hereby proclaim and declare that the 5th, 6th, and 8th Sections of Chapter 73, Title XI, of the Revised Statutes, 'Of the Militia Law,' the 4th Section of Chapter 75, of the same Title, and the 2nd and 3rd Sections of Chapter 80, of the same Title, be and they are hereby declared to be revived and in full force and effect on the following days and times, that is to say:—Thursday the second day of August next, Friday the third day of August next, Saturday the fourth day of August next, Monday the sixth day of August next, and Tuesday the seventh day of August next, so far as relates to the Companies of Militia who have volunteered for drill and exercise, and are severally mentioned and specified in Schedule hereto annexed, and accompanying this my Proclamation.

Given under my Hand and Seal at Fredericton, the twenty fifth day of July, in the year of our Lord one thousand eight hundred and sixty, and in the twenty fourth year of Her Majesty's Reign.

HIS Excellency the Commander in Chief having, by a Proclamation of this day's date, revived the Sections of the Militia Laws therein mentioned, which Sections are now applicable to the several Companies of Militia specified in said Proclamation, His Excellency hereby calls out the said Companies of Militia for the days stated in the said Proclamation, and hereby places them, (until further orders) under the Command of Major CARTER, 63rd Regiment, Commanding Her Majesty's Troops in New Brunswick; and all Orders which Major Carter may from time to time issue, will be complied with in accordance with the usages of the Service.

His Excellency is confident that the same spirit which has induced this portion of the Militia to volunteer for drill and exercise, will mark the performance of their Military Duties; and

His Excellency is sure that they will gladly avail themselves of the opportunity about to be afforded them of presenting before His Royal Highness the Prince of Wales, a Provincial Military Force well qualified by discipline as well as by zeal to serve the Crown, and if necessary, to protect the Province.
