No Petition shall be received at the Crown Land Office until the allegations therein set forth be first verified on oath before a Justice of the Peace, and no approval shall continue in force longer than one year from its date. unless the applicant shall sooner have paid in labour or money, at least one fourth part, together with the Commission, and have cleared at least two acres of the land.
