A PROCLAMATION.

THEREAS by an Act of the General Assembly of this Prow vince, made and passed in the twenty fourth year of Her Majesty's Reign, intituled "An Act to amend Chapter 40, Title IV, of the Revised Statutes, 'Oi the Post Office,'" that it is provided the Governor in Council shall by Proclamation declare the time when the said Act shall come into operation : Now therefore, in pursuance of the power and authority vested in me by the said Act, I do hereby proclaim and declare that the said Act shall come into operation on the first day of June next.

Given under my Hand and Seal, at Fredericton, the sixteenth day of April, in the year of our Lord one thousand eight hundred and sixty one, and in the twenty fourth year of Her Majesty's Reign.

Ordered, That on and after the first day of June next, all Letters posted and for delivery within this Province, and not ' prepaid, shall be subject to an additional charge or rate of two cents each. JAMES STEADMAN, P. M. G.
