#### ADDRESS

To His Excellency The Honorable JOHN HENRY THOMAS MANNERS-SUTTON, Lieutenant Governor and Commander in Chief of the Province of New Brunswick, Chancellor and Vice Admiral of the same, &c. &c. &c.

We, the Mayor, Aldermen, and Commonalty of the City of Saint John, approach Your Excellency on the occasion of your relinquishing the Government of the Province, and consequent departure from our shores.

In taking leave of Your Excellency, we trust that we may be permitted to bear a willing testimony to the unceasing anxiety which, during a prolonged administration of our public affairs, has, on all occasions, been displayed by Your Excellency for the public good, and to the untiring energy with which you have devoted your high administrative talents to advance the best interests of the Province, and the true prosperity of our people. And we hope that, on surrendering to our most gracious Queen the high trust you have now discharged, Her Royal approbation may be accorded to you.

We assure Your Excellency that, in common with the By His Excellency The Honorable ARTHUR inhabitants of every section of the Province, (as we believe,) we shall continue to feel the warmest interest in the personal welfare and happiness of yourself, the Honorable Mrs. Manners-Sutton, and your family; while we have every reason to trust that the remembrance of the years passed among us, when recalled, will not be found unmingled with pleasing recollections of New Brunswick.
