THE Adjutant General has received the following Order. and Notice to Militia and Volunteers, which are published for the information of the Militia Volunteers of this Province:

# MILITIA GENERAL ORDER.

Head Quarters, Adjutant General's Office. Hailfar, N. S., July 17th, 1862.

The Commander in Chief has been pleased to direct the publication of the following regulations with reference to the Nova Scotia Inter-Colonial Prize Cup, which is to be fired for in 1862:-

Ranges-Yards-200, 300, and 400.

Rounds-Five at each range.

FIRING-In squads-Regulation.

Ammunition-Regulation, furnished on the ground; no other ad-

RIFLES-Regulation-Government long Enfield.

Ties-Shot off with three rounds, at 400 yards. Should any competitors count equal points, the one having the greater number of hits will be considered the best shot-equal hits being considered ties to be shot off.

Competitors—Twenty certificated effective Volunteers or trained Militia belonging to this Province; twenty or less effective Volunteers belonging to Prince Edward's Island; and twenty or less effective Volunteers belonging to New Brunswick, certificated by the Adjutant Generals of Militia of their respective Provinces,—all competitors to appear in uniform.

In order to select the best shots from the competitors of this Province, the Commander in Chief has decided to grant preliminary first and second prizes of ten and five pounds, to be competed for on the two days before the firing for the Cup, in the following manner:—

Trained Militia not exceeding six per battalion, will be admitted on nominal requisition and certificate of their commanding officers, endorsed by the A. G. M.

Effective Volunteers not exceeding six per Company, will also be admitted; they are to be selected by their Companies, and are to bear the effective certificate of their commanding officers, endorsed by the

They will fire for the preliminary prizes on the same ground chosen for competing for the Cup, at the same ranges, with the same number of rounds, and under the same regulations.

Metropolitan competitors will fire on the first day. Other competi-

From the aggregate registers, the twenty best shots will be selected for the Cup, which will be fired for on the third day.

Ties, if any, for the preliminary prizes, will be shot for on the

conclusion of the second days' practice.

Temporary discontinuance on account of bad weather, to be at the discretion of the officer conducting the practice.

No departure from any regulations will be permitted without special

commission from the officer appointed to superintend the practice, under penalty of forfeiture of claim to prizes.

It is uncertain yet at what precise time or place the firing will be. Proper and sufficient notice will, however, be given; meanwhile, Companies are to take measures to ascertain such of their best marksmen as are willing to attend, preparatory to returning their names to Head Quarters, without delay, when called upon.

#### NOTICE TO MILITIA AND VOLUNTEERS.

THE NOVA SCOTIA PRIZE RIFLE MEETING FOR 1862.

It has been decided that this meeting shall take place at Truro, on WEDNESDAY, September 10th, no proper range being attainable in the vicinity of the City of Halifax.

The practice will commence as soon after the arrival of the first

Train as convenient.

Competitors are reminded that in every point strict regulation is to be observed.

The "pull off" of competitor's Rifles is not to be under six pounds, and winners Rifles will be tested by a weight, or spring force equalling 6 lbs. attached to the bow of the trigger at full cock.

Any violation of the Hythe Regulations in this or any other point will forfeit the Prize.

A proper Umpire will be appointed to appeal to in all matters of dispute.

Strict silence is to be enjoined by the Superintendents of firing squads, who will suspend practice, should their injunctions in this respect not be complied with.

No spectator will be allowed in the immediate rear of the firing parties, nor on their flanks, and competitors conversing or addressing any competitor while in the act of firing, will be disqualified from further competition on report of Superintendent of his Squad.
