T a Meeting of the Board of Education, held on the 11th instant, the following Explanation and Orders were made :---

EXPLANATION .- The accommodation required in the case of Superior Schools must be such as to ensure in the principal School-room one hundred and fifty cubic feet of air to each pupil, not only on the average during the Term, but on each and every day of it.

## ORDERS.

1. The average daily attendance at Schools in which an Assistant Teacher is employed must be at least forty pupils of six years of age or upwards, to entitle both Teachers to the Provincial Allowance.

2. That in future not more than forty Pupil-Teachers will be received at the Training School in each Term, of whom not over twenty five may be females. If a larger number than forty apply for admission, the applicants will be admitted
