SIR,-I have the honor to annex a copy of a notification By His Excellency The Honorable ARTHUR from the Captain Commanding the French Naval Expeditionary Division in the Gulf of Mexico, addressed to Captain Tatham, of Her Majesty's Ship "PHÆTON," the Senior Officer at Vera Cruz, of the intended Blockade of the Port of Tampico, by a French Naval Force after the 15th ult.

### Vera Cruz, 10th July, 1862.

THE Captain Commanding the French Expeditionary Division in the Gulf of Mexico, has the honor to make known to the Captain of H. B. M.'s Ship "PHÆTON," that after the 15th July, the Port of Tampico will be Blockaded by a French Naval Force, sufficient to ensure an effective Blockade. This blockade will be maintained until the end of hostilities .- Nevertheless the English Packet which takes the European Correspondence can continue as heretofore the monthly voyages to Tampico.
