His Excellency the Lieutenant Governor in Council offers for Competition to each Company of Militia that has volunteered under the present Act, a Silver Medal, to be fired for under the following regulations, as the Commanding Officers of the respective Companies may think fit:-

I. The ranges and rules to be the same as those established this year for the competition for the Prince of Wales's Challenge Cup.

II. The best shot of a Company not to be entitled to the Medal unless he shall have made eighteen points.

III. The name and score of the winner to be forwarded to the Office of the Adjutant General before 30th November.
