WHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the month of April 1863, pass forty one Acts, which have been transmitted, entitled as follows, viz:—

No. 2937. An Act to provide for defraying certain expenses of the Civil Government of the Province.

2938. An Act to provide for the repair and improvement of Roads and Bridges and other Public Works and Services.

2942. An Act in amendment of the Act 21st Victoria, Chapter 9, intituled "An Act relating to Parish Schools."

2943. An Act further to amend an Act intituled "An Act in amendment and consolidation of the Laws relating to Highways."

2944. An Act to amend an Act intituled "An Act to amend the Revised Statutes, Chapter 53, 'Of Rates and Taxes.'"

2945. An Act to amend Chapter 124, Title xxxiv, of the Revised Statutes, "Of Insolvent Confined Debtors."

2946. An Act relating to Physicians and Surgeons.

2947. An Act requiring Justices of the Peace to make due return of the List of Defaulters in payment of Rates placed in their hands for collection.

2948. An Act in addition to an Act intituled "An Act in amendment of and in addition to certain Chapters of Title viii, of the Revised Statutes, 'Of the local government of Counties, Towns, and Parishes.'"

2949. An Act to prevent Nuisances upon Public Highways.

2950. An Act to provide for Securities to be given by Public Officers in this Province.

2951. An Act to amend the Act relating to the Administration of Justice in Equity.

2953. An Act for the further protection of Sheep from Dogs.

2954. An Act to provide for the more efficient discharge of the duties of certain Parish Officers in Incorporated Counties, and for other purposes therein mentioned.

2955. An Act further to amend the Law relating to Courts of Probate.

2956. An Act relating to the Accounts of Commissioners for Sick and Disabled Seamen.

2957. An Act relating to Securities to be given by Deputy Treasurers in this Province.

2958. An Act relating to the admission of Attorneys of the Supreme Court.

2959. An Act to continue an Act intituled "An Act to provide for the attendance and examination on oath of Witnesses before the Legislature, or Committees thereof."

2960. An Act further to provide for the erection of a Public Hall at Carleton, in the City of Saint John.

2961. An Act to repeal an Act made and passed in the 25th year of the Reign of Queen Victoria, intituled "An Act for the alteration and amendment of the local government of the Parish of Portland, in the County of Saint John, and make other provisions in lieu thereof."

2962. An Act to continue the several Acts relating to the establishing and maintaining a Police Force in the Parish of Portland, in the City and County of Saint John.

2963. An Act to amend the Law relating to the Levying, assessing, and collecting of Rates in the City of Saint John.

2964. An Act to continue certain Acts of Assembly establishing a Board of Health in the City and County of Saint John.

2965. An Act further in amendment of an Act for the Incorporation of the Saint John Rural Cemetery Company.

2966. An Act to incorporate the Saint John Pleasure Grounds Association.

2967. An Act to authorize the Rector, Church Wardens, and Vestry of Trinity Church, in the Parish of Saint John, in the City of Saint John, to sell part of their Real Estate in the City and County of Saint John.

2968. An Act in addition to and in amendment of an Act to alter and amend the Act to incorporate the City of Fredericton.

2969. An Act to enable the Corporation of the City of Fredericton to raise a sum of money by way of Loan to pur-
