MILITIA GENERAL ORDERS.

HEAD QUARTERS, FREDERICTON, 15th April, 1863.

HIS Excellency the Commander in Chief has been pleased to direct the following Letter to be published for general information :-

Fredericton, 11th April, 1863.

SIR,-I have the honor to inform Your Excellency that the lowest Tender for making the Volunteer Uniforms is \$2.50 for each Coat. There are two Tenders at this price, one from Mr. Thompson, in St. John, and the other from Mr. Howie, in Fredericton. Mr. Thompson can not agree to make more than twenty Coats per week during the months of May and June, whereas Mr. Howie will undertake to furnish thirty or forty; for which reason, I would submit to Your Excellency that it would be most advisable to accept the tender sent in by Mr. Howie.

The Tender sent in by Mr. Howie has accordingly been accepted. The price to be paid by Volunteers for each coat, including buttons and numbers on the shoulder straps, will be two dollars and eighty cents.

No. 15.

The Militia of each County will be distinguished by a number upon the shoulder strap, and Battalions by their facings. All first Battalions will wear Royal facings, all second sky blue, all third yellow, and all fourth white .---Thus the County of a Volunteer in uniform will be immediately known by his number, the Battalion by his facing.

The Counties will be numbered in the following order, in accordance with the precedent furnished by the Militia List of 1851, where such is the successive arrangement of the Regiments :--

(73)THE Hon. James Davidson, Local Deputy, will offer for sale by Public Auction, at Oak Point, on the first Tuesday in May next, at noon,-Leases for FIVE Years of the following Fishery Stations, viz :-

1st Tract-On Portage Island, to begin at the lower or Captains of Militia who wish to receive Uniforms for the southeasterly end of the said Island, and to extend southwesterly to the line dividing Lots Nos. 10 and 11, and its prolongation to the inside of the Island. Annual Rent-Upset rate, £60.

Companies under their command, are requested to make application at the Office of the Adjutant General.

On approval of the application, a pattern cap and one coat of each size will be forwarded to the Captain, who will then send in a Requisition for the number of each size required by his men. These will be supplied as soon as practicable. Caps can be furnished by Mr. Whittaker, Prince William Street, St. John; but, should they be procured elsewhere, they must be made strictly according to the prescribed pattern.

The coat, buttons, bugles for caps, and other articles supplied from Head Quarters, will be charged against Captains of Companies, and are to be paid for immediately upon August in each year. application for the amount.

2nd Tract-To comprise all the residue of the said Island. Annual Rent-Upset rate, £40.
