

THEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the month of April 1864, pass fifty six Acts, which have been transmitted, entitled as follows, viz :-

No. 2983. An Act to provide for defraying certain expenses of the Civil Government of the Province.

2984. An Act to provide for the repair and improvement of Roads and Bridges and other Public Works and Services.

2985. An Act in aid of the construction of Railways. 2987. An Act to explain an Act intituled "An Act

to amend the Act relating to the administration of Justice in Equity.'

2988: An Act relating to Larceny and other similar offences.

2989. An Act in addition to Chapter 137, Title xxxvii, of the Revised Statutes, 'Of the jurisdiction of Justices in Civil Suits.'

2990. An Act relating to the issuing of Warrants by Justices of the Peace, and in aid of Police Officers and Constables in the execution of their duties.

2991. An Act to amend an Act intituled "An Act to amend Chapter 40, Title iv, of the Revised Statutes, 'Of the Post Office.""

2992. An Act in addition to an Act relating to Steam Navigation in this Province.

2993. An Act to amend the Act to provide for reporting and publishing the decisions of the Supreme Court.

2994. An Act to establish additional Circuit Courts in the City and County of Saint John.

2995. An Act relating to the Savings' Bank in the City of Saint John.

2996. An Act for the alteration of the Local Govern-HEREAS the first day of January one thousand eight ment of the several Parishes of Lancaster, Simonds, and

2997. An Act to extend the jurisdiction of the Police Magistrate of the City of Saint John, in actions of Debt wherein the Corporation of said City is interested.

2998. An Act to enable the Corporation of the City of Saint John to improve the Streets in that part of the City of Saint John on the western side of the Harbour.

2999. An Act for the repayment of certain Moneys expended in the repairs of Sewers in the City of Saint John.

3000. An Act relating to the Harbour of the City of Saint John.

3001. An Act to amend an Act to provide for the erection of a City Hall in the City of Saint John.

3002. An Act to provide for the drainage and protection of the different Marsh Lands in the Parish of Lancaster, in the County of Saint John.

3003. An Act to authorize the County of York to assess for Agricultural purposes.

3004. An Act to provide for more effectually repairing the Streets, Bridges and Sidewalks in the lower Highway District in the Parish of Saint Stephen.

3005. An Act to provide for the erection and maintenance of a Poor House and Alms House in the Parish of Saint George, in the County of Charlotte.

3006. An Act to continue and amend an Act intituled "An Act to incorporate the Petitcodiac Bridge Company."

3007. An Act relating to Grimross Neck, in gueen's County.
