FIXED LIGHT AT ENTRANCE TO LUNENBURG HARBOUR.

The Board of Works at Halifax has given Notice, that on or about the first day of November 1864, a fixed white light will be exhibited from a Lighthouse recently erected on Battery Point, at the entrance to Lunenburg or Malaguash Harbour, on the southeast coast of Nova Scotia.
