





WHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and

Assembly of the said Province, did in the Month of April 1864, pass an Act, which has been transmitted, entitled as follows, viz:—

No. 3026. An Act to facilitate the winding up of the affairs of Incorporated Companies.

And whereas the said Act has been laid before her Majesty in Council, together with a letter to the Lord President of the Council from the Right Honorable Edward Cardwell, one of Her Majesty's Principal Secretaries of State, recommending that the said Act should be left to its operation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to approve the said recommendation: Whereof the Governor, Lieutenant Governor, or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice, and govern themselves accordingly.

Downing Street, 8th November, 1864.

SIR,—I have the honor to transmit for your information the enclosed copy of a Despatch which I have addressed to the Governor of Canada, upon the Resolutions adopted by the Representatives of the several Provinces who assembled at Quebec to consider the subject of Federation.

This Despatch so fully communicates the views of Her Majesty's Government on this important subject, that I need do no more than request of you to take the necessary steps for giving effect to them in the Province under your Government.

MY LORD,—Her Majesty's Government have received with the most cordial satisfaction Your Lordship's Despatch of the 7th ult., transmitting for their consideration the Resolutions adopted by the Representatives of the several Provinces of British North America, who were assembled at Quebec.
