WHEREAS the General Assembly of this Province stands prorogued to Thursday, the nineteenth instant, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued accordingly to Thursday, the thirtieth day of November next.

Given under my Hand and Seal at Fredericton, the seventeenth day of October, in the year of our Lord one thousand eight hundred and sixty five, and in the twenty ninth year of Her Majesty's Reign.

His Excellency the Lieutenant Governor directs the following Circular (with Enclosure) which His Excellency has received from the Secretary of State for the Colonies, to be published for general information.

(CIRCULAR.)

Downing Street, 18th October, 1865.

SIR,—With reference to my Circular Despatch of the 3rd June last, I transmit to you herewith, for your information and guidance, a copy of a further Letter from Earl Russell, announcing that all measures of a restrictive nature on Vessels of War of the United States in British Ports, Harbours, or Waters, are now to be considered as at an end, and that it is the desire and intention of Her Majesty's Government that unrestricted hospitality and friendship should be shown to Vessels of War of the United States in all Her Majesty's Ports, whether at home or abroad.

Earl Russell to Mr. Cardwell.

Foreign Office, October 13, 1865.

SIR,—With reference to my Letter of the 2nd June last, prescribing the course to be taken by Her Majesty's several authorities in all ports, harbours, and waters belonging to Her Majesty, whether in the United Kingdom or beyond the seas, in consequence of the recognition by Her Majesty's Government that Peace was restored within the whole territory of which the United States of North America before the commencement of the Civil War were in undisturbed possession, and with reference more particularly to that passage in my Letter in which it was laid down that Confederate vessels departing in pursuance of requisitions to be made by Her Majesty's authorities from any port, harbour and waters belonging to Her Majesty, in which, at the time of the receipt by those authorities of the fresh orders, such vessels might be found, should then and for the last time have the full benefit of the prohibition theretofore enforced against pursuit of them within twenty four hours by a cruiser of the United States lying at the time within any such ports, harbours, and waters, I have the honor to state to you that

Her Majesty's Government are of opinion that it is desirable that Her Majesty's naval and other authorities at home and in Her Majesty's possessions abroad, should be formally apprised that, as full time has now elapsed since my Letter of the 2nd of June for giving effect to the provisions of that Letter, all measures of a restrictive nature on vessels of war of the United States in British ports, harbours, or waters, are now to be considered as at an end, and that it is the desire and intention of Her Majesty's Government that unrestricted hospitality and friendship should be shown to vessels of war of the United States in all Her Majesty's ports, whether at home or abroad.

I have addressed a similar Letter to the Secretaries of State for the Home and India Departments, and to the Lords Commissioners of Her Majesty's Treasury and the Admiralty.
