A PROCLAMATION.

WHEREAS the General Assembly of this Province stands prorogued to Thursday the ninth day of February instant, I have thought fit to dissolve the said General Assembly, and the same is hereby accordingly dissolved; whereof all persons whom it may concern will take due notice.

And I have further thought fit to order and direct that Writs for calling a new General Assembly be forthwith issued in due form, returnable on Wednesday the twenty ninth day of March next.

Given under my Hand and Seal at Fredericton, the eighth day of February, in the year of our Lord one thousand eight hundred and sixty five, and in the twenty eighth year of Her Majesty's Reign.

POST OFFICE DEPARTMENT.

MONEY ORDER BRANCH.

ORDERED,—

1st. Every Money Order Office in New Brunswick may, if authorized so to do by the Postmaster General, issue Money Orders on such Money Order Post Offices in Great Britain and Ireland, as shall be named for that purpose by the Imperial Authorities, and pay all Money Orders drawn on them by the authorized Money Order Post Offices in Great Britain and Ireland.

2nd. All Orders must be drawn in Sterling money, and may be for any sum not exceeding, on any one Order, Ten Pounds.

3rd. The commission to be charged on Money Orders payable in Great Britain and Ireland, shall be as follows:—

On Orders not exceeding £2, .....1s. Stg.  
On Orders exceeding £2 and not exceeding £5, ...2s. "  
On Orders exceeding £5 and not exceeding £7, ...3s. "  
On Orders exceeding £7 and not exceeding £10, 4s. "

The Commission to be divided between the Imperial and New Brunswick Post Offices.

4th. Every Money Order Post Office in this Province, may, if authorized so to do by the Postmaster General, issue Money Orders on such Money Order Post Offices in either Canada, Nova Scotia, or Prince Edward Island, as may be authorized for that purpose, and to pay all Money Orders drawn on them by any of the said Offices, charging such Commission therefor, as may be agreed upon with the Province interested.

5th. All such Orders to be drawn in Sterling money, and may be for any sum not exceeding on any one Order, twenty five pounds.

NOTE.—By agreement, the amount of any one Money Order is limited to Ten Pounds Sterling.
