To all whom it may concern-Know ye, that in pursuance of the power and authority to us given by virtue of Her Majesty's Commission or Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, bearing date the eighteenth day of May, in the first year of Her Majesty's Reign; We have appointed and do hereby appoint a Session to be holden of the Court constituted by the said Commission, pursuant to the several Statutes in such case made and provided, for the trial of all treasons, piracies, felonies, robberies, murders, conspiracies, and other offences whatsoever, and the accessories thereto, done and vithin the jur committed upon the sea said Court, on Tuesday the thirtieth day of May next, at to approve of the following appointment :the Court House in the City of Saint John in the said Province: Whereof all persons concerned will take due notice.
