BY AUTHORITY.

Government House, 10th June, 1865.

His Excellency the Lieutenant Governor directs the following official notification which he has received, to be published for general information:—

Official.

DEPARTMENT OF STATE,

Washington, 2nd June, 1865.

Whereas, pursuant to the order of the President, and as a means required by the public safety, directions were issued from this Department, under date of the 17th December, 1864, requiring passports from all travellers entering the United States, except immigrant passengers directly entering an American Port from a foreign country; and whereas the necessities which required the adoption of that measure are believed no longer to exist, now, therefore, the President directs that from and after this date, the order above referred to shall be, and the same is hereby rescinded.

Nothing in this regulation, however, will be construed to relieve from due accountability any enemies of the United States or offenders against their peace and dignity, who may hereafter seek to enter the country, or at any time be found within its lawful jurisdiction.

MILITIA GENERAL ORDERS.

HEAD QUARTERS, FREDERICTON, 14th June, 1865.

No. 34.

HIS Excellency the Commander in Chief desires it to be intimated that the Camp of Instruction will assemble at the Exhibition Building in Fredericton, on Wednesday, July 5th.

The rates of pay for Officers and Men in Camp, have been fixed by His Excellency the Lieutenant Governor in Council, as under:—

Field Officers and Captains,	\$3 00	per diem.
Subalterns,	1 50	"
Sergeants,	0 75	"
Corporals,	0 60	"
Privates,	0 50	"

Each man will be furnished by Government with a Cap and Tunic, but will be expected to provide his own under-clothing, Trowsers, and Shoes.

Rations will be provided for the Non-Commissioned Officers and Privates. Commissioned Officers will make their own mess arrangements.

Means of transport to and from Fredericton will also be provided at the Government expense, under regulations to be shortly notified by the Quarter Master General of Militia, or the Officer acting for him.

Pay and rations will commence from the time at which the men leave their homes.

It will thus be seen that lodging, pay, food, and uniform, are all provided, and the means of travelling to and from Fredericton furnished by the Government.
