

The following Regulations will be adopted :—

1. Each Company of Class A of the Active Militia may send one competitor for every six effective Members.

2. There will be three Ranges—200, 300, and 400 yards; five shots will be fired at each range. The standing position will be adopted at the first two ranges, and kneeling (or standing) at the last.

3. The size of Targets will be according to recent Hythe Regulations, viz:—At 200 and 300 yards, four feet wide by six feet in height; bull's eye, two feet by one foot; centre, four feet by two feet. At 400 yards targets will be six feet wide and six feet in height; bull's eye, two feet square; centre, four feet square. The value of hits will be as follows:—Outer, two points; centre, three, and bull's eye, four points.

4. Each competitor must obtain at least 20 points in ten rounds at the first two ranges, in order to qualify to fire at the last.

5. Ties in number of points will in the first instance be settled by the number of hits. If hits as well as points are equal, by one shot at 400 yards.

6. Each competitor will parade at the Camp, Torryburn, near Saint John, on the 18th October next, at 9.30 A.M. in Uniform, with the Rifles and Accoutrements which have been issued to them by Government, and will receive ammunition on the ground.

7. Temporary discontinuance on account of bad weather to be at the discretion of the Officer conducting the Practice.

8. An Umpire will be appointed by His Excellency the Commander in Chief.

9. The successful competitor for the Challenge Cup will receive either a Gold Medal or a Prize of Fifty Dollars; and other Prizes will be given to some of the best shots next in succession, in proportion to the numbers competing.

In addition to the Prizes offered to Volunteers, a Prize of Thirty Dollars will be offered to be competed for by Officers of the Militia of Class B and C only. Officers must appear in the Uniform of their Battalion, and the names of intending competitors must be sent into the Adjutant General of Militia, Fredericton, on or before the 25th September. This Prize, however, will not be given, unless at least fifteen Officers intimate their intention of competing.

His Excellency the Commander in Chief has also the satisfaction of informing the Volunteers, that the National Rifle Association of Great Britain has forwarded a Silver Medal to be competed for by the Volunteers of this Province. It will be competed for at the same time and place as His Royal Highness the Prince of Wales' Challenge Cup.

The Rules will be as follows :—

Each Volunteer Company in the Province may send one competitor; but when the Company exceeds fifty effective members, two may be sent. The competitors must have been effective Volunteers for at least three months previous to the nomination, which will be made by the Officer commanding the Company.

Each Company sending competitors to subscribe one dollar for each.

Those entering for this Prize may either be competitors for other Prizes or not.

Five rounds will be fired at 500, and five at 600 yards. The arms and method of counting to be the same as other Prizes. Any one failing to make six points at 500 yards to be struck out.

The winner of the Medal will be entitled to fire for Her Majesty's Prize, value £250 sterling, at Wimbledon, next year.
