#### A PROCLAMATION.

BY virtue of the power and authority by Law vested in the Governor in Council, I hereby declare and proclaim to all whom it may or doth concern, that I have, by and with the advice and consent of the Executive Council, increased the extent of the Port of Saint George, in the County of Charlotte, so as to include that part of the Parish of Saint Patrick lying east of a division line described as follows, viz :- Beginning on the shore of Passamaquoddy Bay, at the southeastern angle of the Lot of Land granted to John Boyd, at the mouth of the Bocabec River ; thence running northerly along the eastern boundary of said granted Lot, and its northern prolongation, until it meets the southern boundary of Lot number ten, granted to Thomas J. Bailey; thence easterly along the same to the rear of Lot number twenty seven, granted to Hugh Stewart; thence northwesterly along the rear line of said Lot number twenty seven, and the Lots to the northwest of it fronting upon the west side of the Digdeguash River, until it comes to the northwesterly angle of Lot number one, granted to Daniel Little; and thence northwesterly along a prolongation of the last mentioned line to the line dividing the Parishes of Saint Patrick and Dumbarton, which includes the Port known as the Port of Digdeguash : And the above described District is hereby constituted and appointed a part of the Port of Saint George, subject to the like regulations, as far as the same are applicable, that the Port of Saint George now possesses or is subject to, and the boundaries of the

Port of Saint Andrews are reduced to the extent of the limits herein described.
