The following Address to Sir James Carter, Knight, was adopted by the Bar Society at last Michaelmas Term, but in consequence of his illness the presentation of it was necessarily deferred until to-day, when it was presented in the Law Library by the Honorable A. J. Smith, Attorney General, and such Members of the Society as were in Fredericton.

TO SIR JAMES CARTER, KNIGHT.

Sir,—The Members of the Barristers' Society of New Brunswick cannot permit your retirement from the high office of Chief Justice of this Province, which you have so ably and impartially filled, to pass, without an expression of their deep regret for the loss the Bench has sustained in the resignation of one who, for upwards of thirty years, has so universally and deservedly commanded the respect and esteem of the profession.

In the discharge of your official duties we cordially and without flattery tender you our highest appreciation of the amenity of manner in which you ever clothed a strict impartiality; and of your readiness at all times to listen to the suggestions of Counsel, however at variance with your own impressions of rotes,—a quality in a Judge most important to suitors, whose rights and liberties are in this respect so dependent upon an accurate record being kept of evidence, and of circumstances which may transpire in the hurry of a trial.

Your retreat from public life, surrounded as we trust it may be with many pleasing reminiscences, cannot but remind the public of how many of its faithful servants with whom your earliest associations in this Province were connected, have passed away forever; but it must be a subject of great gratification to that same public that a gentleman now occupies the dignified position you so lately held, whose judicial labours, undoubted talents, and estimable character, have placed him deservedly high in the public estimation, and who we hope will receive from our gracious Sovereign a similar mark of Her Royal approbation as that conferred upon yourself.

We are gratified to see that your vacancy on the Bench has been filled by a Gentleman whose appointment to this important office claims our warm approval, and secures to the country another impartial administrator of its laws.
