GOVERNMENT NOTICE.

HIS Excellency the Lieutenant Governor in Council has been pleased to abolish the Fishery Districts numbered 5, 6, and 7, and to constitute and appoint in lieu thereof, during the open season, the following, to be known as open Districts, namely:—

No. 5. To comprise all that part of the Miramichi River and Bay, and their Tributaries, lying below the easterly end of Beaubear's Island, situate or being within the Parishes of Alnwick and Newcastle.

No. 6. All that part of the said River and Bay, with their Tributaries, lying below the easterly end of Beaubear's Island, situate or being within the Parishes of Hardwicke, Glenelg, Chatham, and Nelson.

No. 7. All the North West Miramichi River and its Tributaries, from the lower or easterly end of Beaubear's Island upwards.

No. 13. All the South West Miramichi River and its Tributaries, from the lower or easterly end of Beaubear's Island to Boiestown.

And in lieu of the said Districts so abolished, during the close season, the following to be designated Close Fishery Districts, (Miramichi,) namely:—

Letter A.—All that part of the South West Miramichi from the lower or easterly side line of the Elm Tree Tract to the lower or easterly side line of the Lot presently occupied by John DeCantillon, in the Parish of Blissfield.

B.—All the South West Miramichi River and its Tributaries from the upper boundary of District A to Boiestown.

C.—The whole of Burnt Church River and its Tributaries.

D.—The whole of Cain's River and its Tributaries.

E.—The whole of Renous River and its Tributaries.

F.—The whole of the Little South West River and its Tributaries.

G.—The whole of the North West Miramichi River from Beaubear's Island upwards, except the Little South West.

H.—The whole of Bartibog River and its Tributaries.

I.—The whole of Tabusintac River and its Tributaries.

J.—The whole of Napan and Black Rivers and their respective Tributaries.

His Excellency has also been pleased to order that from the first day of May to the thirty first day of August inclusive in each year, shall be the open season, and the remainder of the year shall be the close season.

His Excellency the Lieutenant Governor in Council has also been pleased to appoint the following persons to be Fishery Wardens, during the open season, of the following Districts, namely:—

Andrew Grant, of District No. 5.

Amos Perley, of District No. 6.

James M'Gee, of District No. 13.
