CROWN LAND OFFICE, 15th August, 1865.

Each applicant in this list must on or before the 16th August, 1866, have cleared and cultivated not less than 2 acres on the lot approved to him, and paid in money or labour not less than one quarter of the purchase money, or else the approval will be cancelled.

Commissioners under the Labour Act are reminded that they have no authority to assign labour to any applicant until his Petition shall have been approved by publication in the Royal Gazette; and labour returned for any applicant before approval of his Petition, will not be credited.

No person is entitled to the privileges of the Commutation Act on Land purchased after March, 1849.
